### **Subject to Validation**

Some courses are subject to formal course approval, accreditation and validation at regular intervals by the Cyprus Agency of Quality Assurance and Accreditation in Higher Education (CYQAA) and by UCLan under QAA, UK framework, along with other related external professional bodies, which may result in changes to the course structure or availability. Course and module information are updated accordingly, with the outcome from these approval and accreditation processes. #### **Entry Requirements**

UCLan Cyprus' entry requirements will vary depending on the individual course and the year of entry. Any reference to typical entry qualification or grades stated on the website are provided as a guide only. There is no guarantee that applicants who have, or are predicted to achieve, grades equivalent to or exceeding typical entry qualifications or grade will be made an offer by UCLan Cyprus.
